CLARIFICATION NO.3 TO THE BIDDING DOCUMENTS

The PAIP TFSU would like to issue the following clarification in response to questions asked by bidders in relation to the above named tender. The questions and answers are provided below:

According to the tender documents, in page 101 of the bidding documents, Technical Specifications for Fua'amotu New Control Tower Building.</p> <p>1.6 <i>Section 4 below details the requirements for separate systems. It is permissible to aggregate two or more systems into a single supply package if that offers costs savings and also meets interoperability requirements across all other ATC operational equipment as may be required to provide the Tonga Airports Limited (TAL) Air Navigation Service.</i></p> <p>Is it possible for 1 single bidder to submit a proposal for the following?</p> <ol style="list-style-type: none"> 1. Proposal for Lot 1 2. Proposal for Lot 2 3. Proposal for Lot 3 4. Proposal for Lot 4 5. Proposal for Lot 1,2,3 and 4 (As a single supply package) <p>In case proposal aggregates two or more systems into a single supply package, please confirm if the Prices Schedules can be modified accordingly.</p>	<p>Refer Question 3 of Clarification No.2 as follows:</p> <p>Please refer to Section II. Bid Data Sheet (BDS), ITB 1.1 which states that Bids will be evaluated and contracts awarded on lot basis. Bidders may bid for one or more lots and may offer discount/s for the award of combination/s of lots.</p> <p>And ITB 13.1 which states that Alternative Bids shall not be considered</p> <p>Therefore, aggregation of two or more systems into a single supply package is not acceptable. Prices shall be provided per lot; however the bidder may offer discount if bid for more than one lot. No alternative pricing will be considered.</p>

According to the tender documents, in page 101 of the bidding documents, Technical Specifications for Fua'amotu New Control Tower Building.</p> <p>2. <i>Drawings</i></p> <p>2.1. <i>A relevant subset of the project drawings will be included in the bid documents.</i></p> <p>We have not found any drawings in the tender documents received. Could you please forward them?</p>	<p>The Drawings can be found here.</p>

<p>3. Does the legal/administrative documents such as power of attorney, articles of incorporation and Annual Turnover, etc shall be included in every LOT envelope or we can submit one unique envelope for the legal/administrative documentation that is the same for each lot?</p>	<p>One package of administrative documentation may be submitted for all lots bid on.</p>
<p>4. When it says “the bidder shall furnish documentary evidence to demonstrate that it meets minimum average annual turnover”, it means we shall submit the financial statements? If so, of how many years?</p>	<p>Such documentary evidence may include, but not limited to financial statements, bank statements, confirmation of available line of credit, etc.</p>
<p>5. Does the Documentary Evidence requirement consisting in Satisfactory Operational Certificates for international airports in past 3 years, must be from the final user/client?</p>	<p>Section III. Evaluation and Qualification Criteria requires the Bidder to furnish documentary evidence to demonstrate that the Goods it offers meet the technical specifications, and have been in satisfactory operation in international airports over the last three years. Satisfactory Operational Certificates from the final user/client may be accepted as documentary evidence.</p>
<p>6. Does the Similar Experience Form, shall be fulfilled in specific for the goods offered in each lot?</p>	<p>Yes</p>
<p>7. In reference to the same bid, I kindly ask you to confirm that point 4 of the Procurement Notice is a typing error. In fact it says that “Supply and installation and related services are to be completed within 0 (zero!) days of Contract Commencement” .</p>	<p>Please refer to Section VII. Schedule of Requirements, List of Goods and Delivery Schedule as well as List of Related Services and Completion Schedule which establish delivery and completion times per lot.</p>
