The Pacific Aviation Investment Program (PAIP) has received financing from the World Bank toward the cost of the Pacific Aviation Safety Office (PASO) Reform Project and intends to apply part of the proceeds for consulting services.

The consulting services ("the Services") includes **a PASONet Project Manager**. It is anticipated that the consultant will commence as soon as possible. Inputs are expected to be periodic, over a 6-month contract period. The estimated budget for this assignment will not exceed USD 70,000.

The PASO now invites eligible consultants ("Consultants") to indicate their interest in providing the Service. Interested Consultants should provide information:

- a) (CV) demonstrating that they have the required qualifications and relevant experience to perform the Services and

- c) Financial proposal against deliverable in the TOR

The Consultant shall have the following experience and qualifications but not limited to:

- 1) *Relevant Information Technology tertiary qualification from a recognized institution;*
- 2) *At least 7 years of relevant work experience in a similar capacity;*
- 3) *Demonstrated experience in identifying and introducing IT systems and projects into organizations with diverse stakeholders and tight timelines;*
- 4) *Demonstrated ability to work independently and with stakeholders as required;*
- 5) *Excellent verbal, written and presentation communication skills in English, with demonstrable high-level reporting skills;*
